Instructions for submitting applications to the individual arrangements expert panel

Please fill in the application carefully; the expert panel will process only applications that include the details listed in these instructions and the required expert statements attached to the application. Please check that your personal details are displayed in the expert statements you attach to your application. If necessary, the secretary of the expert panel can request supplements to your application. This may postpone its processing to the following meeting. The individual arrangements expert panel convenes approximately four to eight times per academic year.

Pay particular attention to item four (4) below to ensure that you will obtain the best possible individual arrangements suited to your specific circumstances. If you do not know what kind of individual arrangements could support your studies, or if you require other kinds of support, you should first contact the accessibility contact person of the relevant on-site service team. If necessary, they can direct you to, for example, a student advisor or guidance for individual arrangements provided by a counselling psychologist.

5. Matters to be included in the recommendation of the expert panel

In your application, indicate whether you wish to mention in the recommendation, in any way, your diagnosis or impediment. You have the right to have your recommendation state only that it is based on health reasons. However, the recommendation can include reference to, for example, visual impairment, difficulty related to reading or writing, difficulty with attention and executive function, or a pain state that affects concentration and work. In such cases, teachers can gain an understanding of the causes or background of your circumstances, making it possible for them to take your situation into consideration more broadly in teaching. In the recommendation, teachers are instructed to familiarise themselves with the guidelines for individual arrangements in a range of circumstances, which are aimed at describing the consideration, in teaching, of various functional restrictions affecting studying.

6. Attachments

The application must be accompanied by a statement or certificate by a healthcare professional that you have a genuine need and a justification for individual arrangements. In the case of difficulty related to reading or writing, you can also submit a statement by a special needs teacher. Please make sure your personal data are indicated in the attachments.
